Government's Net Revenue Collection: October 2022

Mr. Pornchai Thiraveja, Director General of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the government's net revenue collection in October 2022, the first month of the fiscal year 2023, was 232,207 million Baht. The collected revenue was 33,611 million Baht or 16.9% higher than the revenue target and 19.5% higher than the same month of the previous year. The collected revenue from the Revenue Department, especially Personal Income Tax and Corporate Income Tax, was higher than the revenue target following economic expansion. Meanwhile, the revenues from Other Government Agencies and the Customs Department exceeded the targets due to special revenues from a remittance of extra-budgetary fund's excess liquidity and additional import duties from a court ruling. Nevertheless, the collected revenue from the Excise Department was lower than the target as a result of the temporary tax cut on diesel to alleviate the impact of high energy prices. Excluding special revenues from Other Government Agencies and the Customs Department, the government's net revenue collection was 11,627 million Baht or 5.9% higher than the revenue target and 8.2% higher than the same month of the previous year.
